## MINUTES OF A REGULAR MEETING OF THE COUNCIL OF WAITE HILL, OHIO

January 10, 2022

Pursuant to notice given, the Council of the Village of Waite Hill, Ohio, met at the Waite Hill Village Hall at 8:00 a.m. on Monday, January 10, 2022, with Mayor Robert A. Ranallo presiding. The following members of Council were present:

Mr. Cox, reporting for Ms. Merritt on behalf of the Communications and Community Outreach Committee, indicated that the Newsletter is being prepared for release in February 2022 and that the recycling program will begin in March.

Mr. Scheucher reported on behalf of the Finance Committee, that there had been a meeting earlier in the morning. He stated that the fund balance of the Village stood at \$9,330,000 at the end

of 2021, a reduction of \$112,000 from the prior year. The purchases of several financial instruments were also ratified.

Ms. Hiltsley reported on behalf of the Planning and Zoning Commission and Architectural Board of Review that a garage had been approved on a Metcalf Road property, the re-siding of a garage on Rollin Road was approved, a lot reconfiguration on Gardenside had been denied and that a decision on a barn on Hobart Road had to be deferred, until enough disinterested members of the Commission and Board are present to permit a member to abstain from voting and still have a quorum. Solar panels were discussed, and they are currently not permitted under the code. The Commission may study this matter further. Mr. Cox reported that he had communicated with Pete McDonald of the Western Reserve Land Conservancy about maintaining the split rail fences on the conserved properties in the Village.

Mr. Knezevic reported on behalf of the Safey Commission that many trees have fallen in the Village, taking out electrical wires. Traffic citation counts are down, and that there were two (2) suicides. The Chief reported that a protection order was issued for a resident of the Village, and that the police department has gone through taser training (to keep current in the field).

Mr. Haynik, reporting for Ms. Merrit on behalf of the Service Committee, agreed with the Mayor that somehow heavy snow always seems to fall on garbage days. The Village's trucks are holding up well, and the Village has plenty of salt available for this year's snow season. There was a discussion regarding tree removal by the Village's residents, and the Chief is pursuing the removal of trees that threaten the Village's rights of way.

Mayor Ranallo reported that his negotiations with Willoughby Hills for Fire and EMS have not progressed much since last month. He continues to receive calls from people who want to purchase land/homes in the Village.

There being no other matters before the Council, Mr. Knezevic moved to adjourn the meeting, which motion was seconded by Mr. Steudel.
