In the absence of Ms. Merritt, who heads the Communication and Community Outreach Committee, the Mayor noted that the Village Newsletter was mailed out prior to the Holidays.

Mr. Scheucher reported on behalf of the Finance Committee. The Finance Committee's Minutes were approved. There was a deficit of \$270,000.00 for the fiscal year 2022. Property values are about the same from fiscal year 2021. A Wichert representative came to the Village and spoke with Village representatives regarding the Village's insurance.

Ms. Hiltsley, reporting on behalf of the Planning and Zoning Committee, noted that a residence in Creawood received approval of the color of proposed sandstone quoins. A color rendering will be brought in to convey the final look of the residence. A Gardenside Drive residence's new fence was approved. The Chairman of the Planning & Zoning Commission and/or Architectural Board of Review will send a letter to the Rollin Road residence regarding adhering to plans that have been approved by the P&Z and ABR.

Reporting on behalf of the Safety Committee, Mr. Knezevic noted that this year has been consistent with last year with respect to the number of calls into the department. Chief Dondorfer noted that the Village managed the most recent winter storm well. Assists to other departments are on par with last year. A Gardenside resident went to the hospital, as a result of an emergency wellness check, which uncovered that the resident's living conditions are deplorable, and it is likely that Adult Protective Services will not permit her to return to her home. Part-time hours were down in 2022, but overtime hours are up. The new full-time patrol officer will reduce the need for overtime.

Councilmember Brian Doty excused himself from the meeting at 9:00 a.m.

In the absence of Ms. Merritt, Mr. Haynik noted that, again, the most recent winter storm began on a scheduled rubbish day. The Village will meet its salt requirement for the 2022-2023 season. The quote for salt for the 2023-2024 season has not yet been obtained. The Village has scheduled the purchase a new plow truck in 2024 and has to begin the purchasing process now. The most recent storms, though well managed, were quite impactful, and a lot of fallen trees need to be cleaned up – mostly on private property.

Mr. Knezevic moved to adjourn to executive session to discuss the compensation of employees and Village officials. Mr. Cox seconded the motion.
