Ms. Hiltsley reported on the projects that are currently before the Planning and Zoning Commission, including the approval of a pool house on Reserve Drive. There had also been a discussion regarding the Riddle lot split.

Ms. Winterer will be chairing the Safety Committee. Lieutenant Gerics reported on some of the incidents that had occurred in the previous month. Mutual aid to neighboring communities increased during the holiday season. There have been calls about gunshots being fired, and there was discussion surrounding the fact that a Gardenside resident is now subject to guardianship.

Mr. Doty will be reporting on behalf of the Service Department. Mr. Doty deferred to Mr. Haynik, who reported that there is a surplus of road salt as there hasn't been very much snow. The new salt shed is still being considered, but probably won't be purchased in this current fiscal year. Finally, the Christmas lights on the tree in front of Village Hall were discussed.

Council will present a Resolution to Robert A. Ranallo in the month of February or March, to commemorate his many years of faithful service to the Village.

There being no further matters before Council, Mr. Scheucher moved to adjourn the meeting, which motion was seconded by Mr. Steudel.

Finance Committee Report – January 8, 2024, Meeting

The Committee executed its standard agenda approving the November meeting minutes.

Property tax deposits were completed in September and there are no further property tax revenues for 2023. Property tax revenue including current collections, delinquency collections, and reimbursements totaled \$1,108,081 in 2023. The Auditor's "Schedule A" report projecting property tax to be collected in 2024, issued at the very end of December, estimates the total 2023 tax to be collected to be \$1,072,086 (at 94% compliance level). This is an increase of 3.3% compared to the prior year's corresponding estimate.

2023 Local Government Fund revenue finished at \$177,595, which is \$4,057 ahead of the 2022 revenue.

2023 interest income is \$166,548 running behind 2022 by \$3,155.


Total revenue for 2023 was \$1,645,903, \$15,172 less than 2022 revenue that totaled \$1,661,076.

Total expense for 2023 was \$1,835,396, \$74,074 less than 2022 expense that totaled \$1,909,470.

Regarding total funds, balances ending December vs. November were lower, changing by \$(90,006). Balance ending November 2023 was lower than November 2022, changing by \$(183,379). Total fund trajectory estimates show December 2018 calculated to be \$10,094,736 vs. December 2028 projected to be \$8,328,057, a decline of \$1,766,679 over 10 years, said decline averaging \$176,668 per year, an average decline rate of -2.12% per year. The trajectories continue to flatten slightly predicting a lower deficit rate going forward (for the moment).
