Mr. Cox, reporting on behalf of the Communication and Community Outreach Committee, announced that the recycling program will be starting this coming April. Mayor Ranallo will be drafting the Mayor's portion of the newsletter letter and Ms. Merritt will provide the information for the recycling program that will be included.

Mr. Scheucher reported on behalf of the Finance Committee that the Committee had met and approved the previous month's meeting minutes. The Village's fund balances are down about \$100,000.00 from last year. Property taxes were up, Health District charges were up, and expenses were down \$15,000.00.

Ms. Hiltsley reported on behalf of the Planning and Zoning Commission and Architectural Board of Review. Ms. Kerry Bowden had joined the Commission and the Board. A generator was approved for a residence on Smith Road, an attached garage was approved for an Eagle Road property, a garage on Mountainview Drive was not approved because a variance was needed, and a shed for a property on Hobart Road was approved. There is an issue on Rollin Road where a home renovation has deviated from approved plans. The Planning and Zoning Commission will also be considering whether solar panels should be permitted in the Village.

Mr. Knezevic reported on behalf of the Safety Committee. The weather has wreaked havoc throughout the Village. The Village had mutual aid assists for neighboring communities that may have been a consequence of staffing issues in those communities. The Village also received mutual aid on a false alarm call. There were many weather-related calls. There was also discussion regarding the staffing of the Village's police department.

Mr. Haynik reported, on behalf of the Service Department, that it has been a busy winter. The heavy snows have been a challenge to waste collection days. Metcalf Road tree issue(s) may require the closing of the road on Saturday, March 19, 2022. There was continued discussion regarding the Tree Program. Hobart Road may be completed this year.

There was discussion regarding the levy and whether or not it can be removed from the ballot. A special meeting will be scheduled if the levy can be removed from the May, 2022 primary ballot.

There being no other matters before the Council, Mr. Scheucher moved to adjourn the meeting, which motion was seconded by Mr. Cox.
