Resolution No. 2016-14 - "A Resolution accepting the rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Auditor" was read. After discussion, Mr. Scheucher moved that said Resolution be adopted as read, which motion was seconded by Mr. Steudel.

Advance of funds authorized

Ms. Merritt, on behalf of the Communications and Community Outreach Committee, reported that about one-third (1/3) of the Village has provided email addresses, so the Village may deliver the Village Voice electronically. The Village will continue to collect email addresses. The residents will also be asked for their email addresses at the Halloween party.

Mr. Scheucher noted that the county had not yet distributed the property tax for this half of the year, necessitating the fund advance earlier in the meeting. He also reported that the Finance Committee had acted on its agenda items.

Mr. Knezevic had no report from the Planning and Zoning Commission because there was no Planning and Zoning meeting in August, 2016. A neighbor dispute continues in the Creawood/Metcalf Road area, but no Village action is required.

In the absence of Mr. Taplin, Chief DeWitt discussed the police report and noted that grant funding is being pursued. He also noted that a police cruiser will be delivered by the end of the year, and the truck for the Service Department had been ordered.

The Mayor reported that the Village has placed the Village's surplus tractor with GovDeals, and has placed a reserve on it of \$30,000. Crack sealing is also being performed in the good weather.

Mr. Steudel moved to adjourn to executive session for the purpose of discussing the appointment, compensation, and discipline of Village employees. Mr. Gale seconded the motion.
