Council President Cox called to order the public hearing for Ordinance No. 2022-10 (As Amended) at 8:12 a.m. No one spoke. Council President Cox closed the public hearing at 8:13 a.m.

Ordinance No. 2022-10 (As Amended) - "An Ordinance amending Section 1141.15 of the Codified Ordinances of Waite Hill Village to enact new regulations applicable to accessory uses and structures, to regulate above ground pools, to amend the regulation of the landscaping of fences, and to permit and regulate power conversion facilities." was read for the third time.

Ms. Merritt, reporting on behalf of the Communication and Community Outreach Committee noted that the Halloween Party will be held Saturday, October 22, 2022 at Village Hall, from 5:00 p.m. to 7:00 p.m.

There was no meeting of the Finance Committee as Chairman Scheucher, Mayor Ranallo and Mr. Doty were out of town, but the County Auditor predicts an increase of Village revenues of \$117,000 in 2023. It was also noted that the Village's insurance coverage is being reviewed.

Ms. Hiltsley, reporting on behalf of the Planning and Zoning Committee noted that a proposed new house in Creawood Forest needed a few minor changes. The drawings will also need to be stamped by an architect. A vacant property at Eagle and Smith Roads was sold.

On behalf of the Safety Committee, Mr. Knezevic noted an interesting accident report from August. There have also been calls regarding domestic disputes.

Ms. Merritt, reporting on behalf of the Service Committee noted that the Hobart Road paving is scheduled to be done next week. There will be road striping performed this year. There is a chance that Covid funds could be used to construct a new salt shed. There is no vendor yet for the split rail fence repair, which is a very small project. Options are being explored.

Council held various discussions, which included a Reserve Drive property. Also discussed was the Village's recycling program, as was Chesterland's program. The Village's shredding program is continuing next year.

After discussion, Mr. Knezevic moved to adjourn to executive session to discuss the appointment and compensation of employees and Village officials. Ms. Merritt seconded the motion.
