## **ORDINANCE NO. 2018-10**

## AN ORDINANCE

AMENDING SECTION 1305.02(a) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF WAITE HILL, OHIO, TO ESTABLISH A FEE FOR THE DEMOLITION OF A RESIDENCE OR ACCESSORY STRUCTURES, REPEALING CERTAIN ORDINANCES, AND DECLARING AN EMERGENCY.

WHEREAS, Council finds and determines that the Village needs to charge a fee for the processing of an application to demolish a residence to defray certain costs of government which are incurred by the Village for the review and approval of a proposal to demolish a residence or accessory structure and should therefore be borne by the private property owner rather than the Village's taxpayers, generally.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF WAITE HILL, LAKE COUNTY, STATE OF OHIO:

SECTION 1. That existing subsection (a) of Section 1305.02, "Permits, Plans and Numbering Buildings" of the Codified Ordinances of the Village of Waite Hill is amended as follows:

## "1305.02 VILLAGE ZONING/BUILDING FEE.

(a) At the time of the filing of an application for a Zoning Certificate for the construction, repair, alteration, remodeling, or modification, or demolition of a building or accessory structure, the applicant shall pay the following fees to the Village Clerk-Treasurer:

<b>Project</b>	<u>Fee</u>
Construction of a new residence	\$2,500
Exterior remodeling of a residence or accessory building (substantial)	\$750
Construction of a new accessory structure (except a shed or fence)	\$250
Erection of a new shed	\$100
Demolition of a residence	\$50
Demolition of an accessory structure with attached utilities	\$25
Demolition of an accessory structure with no attached utilities	\$0
Exterior remodeling of a residence or accessory building (minor)	\$0

Repair or replacement of an existing shed	\$0	
Cosmetic remodeling of a residence or accessory building	\$0	
Erection or replacement of a fence	\$0

SECTION 2. That existing subsection (a) Section 1305.02 of the Codified Ordinances of Waite Hill, Ohio, and any ordinances in conflict herewith, are repealed.		
SECTION 3.
