

**RESOLUTION NO. 2024-13**

**A RESOLUTION  
ACCEPTING THE RATES AS DETERMINED BY THE  
BUDGET COMMISSION AND AUTHORIZING THE  
NECESSARY TAX LEVIES AND CERTIFYING THEM TO  
THE COUNTY AUDITOR.**

WHEREAS, this Council, in accordance with the provisions of law, has previously adopted a tax budget for the next succeeding fiscal year, commencing January 1, 2025; and

WHEREAS, the Budget Commission of Lake County, Ohio has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is outside, and what part inside the ten mill tax limitations.

**NOW, THEREFORE, BE IT RESOLVED B THE COUNCIL OF THE VILLAGE  
OF WAITE HILL, STATE OF OHIO:**

SECTION 1. That the rates as determined by the Budget Commission in its certification, be and the same are hereby accepted.

SECTION 2. That there be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied inside and outside the ten mill limitations as follows, and as shown in greater detail on the attached schedule, which is appended hereto and incorporated herein by reference:
